

**FORUM Credit Union  
Student Survival Promotion 2009**

**OFFICIAL RULES**

- 1) **Contest Sponsor:** FORUM Credit Union
- 2) **Eligible Participants:** Current or Potential Members of FORUM Credit Union who are 16 years of age to 24 years of age; and who are U.S. Citizens or non-U.S. Citizens who pay U.S. taxes. Subject to paragraph 5 below.
- 3) **To Enter:** The contest begins July 1, 2009 and ends on September 30, 2009. Eligible Participants are automatically entered into the random drawing by opening a Student Survival Account. This can be done at any FORUM branch location or by visiting [www.forumcu.com](http://www.forumcu.com). See paragraph 11 below for an available "no deposit necessary" exception.
- 4) **Drawing:** FORUM Credit Union will conduct a random drawing to select contest winners on or about October 5, 2009 from all eligible entries received between July 1, 2009 and September 30, 2009. Odds of winning are based upon number of entries. The credit union reserves the right to end the drawings at any time without notice or to make adjustments to the timing and amount of prizes at any time without notice.
- 5) **Eligibility Exceptions and General Terms:** Employees and volunteer officials of FORUM Credit Union and its affiliates, their immediate families (spouse, parents, children, siblings, and their spouses), and individuals living in the same household of each of the above are ineligible. Additionally, any member who has now or in the past defaulted under a FORUM Credit Union agreement, or otherwise caused a loss to the credit union are also ineligible. FORUM Credit Union organization and business accounts are ineligible. Contest void where prohibited or restricted by law. Federal, state, and local taxes are the sole responsibility of the prize winner. Contest is subject to all applicable federal, state (Indiana), and local laws and regulations.
